Applicants who are current members of the Albany Blue Collar Workers Union Local 1961/AFSCME NY Council 66 will be given preference over external candidates, unless the position is entry-level.

Residency Requirement: **YES, but eligible for waiver.**
Per City Code § 62-1, all individuals hired by the City of Albany municipal government must be or become residents of the City of Albany within 180 days of hire. Failure to move into the City shall be deemed a voluntary resignation.
Due to difficulty in filling this position, the City will seek a waiver of the residency requirement (from the Residency Board) for the individual hired.

LICENSED AUTOMOTIVE INSPECTOR

DISTINGUISHING FEATURES OF THE CLASS: The incumbent in this class performs skilled repair and maintenance work on a variety of automotive equipment and machinery. This is skilled work involving responsibility for the efficient performance of mechanical repair and maintenance work of ordinary difficulty on a variety of automotive equipment and machinery, including NYS inspections on all department vehicles and equipment. General instructions from supervisors are received regarding tasks to be performed but incumbents are permitted wide latitude and independent judgment in performing the details of the work.

TYPICAL WORK ACTIVITIES: (Illustrative Only)

- Performs NYS inspections on NYS registered vehicles, gasoline and diesel engines, heavy-duty equipment, excavating and earth moving equipment and a variety of trailer types;
- Performs general mechanical repair and maintenance work on automobiles, light and heavy trucks, tractors, bulldozers, backhoes, cement mixers, motorcycles, sweepers, graders, pumps, hydraulic systems and other automotive equipment and machinery;
- Repairs, replaces, disassembles, overhauls, adjusts or rebuilds gasoline motors, radiators, transmissions, differentials, carburetors, shock absorbers, clutches, brakes, front and rear axle assemblies, drive shafts, cylinder sleeves and pistons;
- Repairs or replaces ignition and electrical systems, hydraulic systems, and steering mechanisms;
- Repairs or replaces fuel pumps, generators, alternators and starters;
- Tunes engines and sets timing;
- Aligns wheels, changes tires, and repairs flats;
- Performs preventive maintenance work by checking a variety of automotive equipment and machinery for worn, damaged or defective parts by visual inspection, road tests or by using testing devices and recommends and performs needed repairs;
- Makes welding repairs to automotive equipment and machinery;
- Mounts snowplows, sanders and auxiliary equipment and connects hydraulic systems to vehicles;
- Performs minor body and fender work;
- Maintains records including filing and computer data entry pertaining to work performed and maintenance of parts and equipment used;
- Schedules and supervises all maintenance and repair work for mechanics and mechanic helpers;
- Maintains inspection and calibration of inspection station and equipment;
- Enters and retrieves information in an automated information system;
- Performs related work as required.

FULL PERFORMANCE KNOWLEDGE, SKILLS, ABILITIES AND PERSONAL CHARACTERISTICS:

- Good knowledge of standard automotive repair methods, practices, tools, terminology and safety precautions;
- Good knowledge of NYS inspection standards and use of inspection equipment;
- Good knowledge of a vehicle inspection program;
- Good knowledge of the principles of internal combustion engine operation;
- Good knowledge of automotive electrical systems;
- Working knowledge of personal computers;
- Demonstrated ability to make repairs on a variety of automotive equipment;
- Ability to locate and adjust motor equipment defects;
- Ability to diagnose engine trouble and test repair equipment;
- Ability to work from plans, specifications and rough sketches;
- Ability to follow oral and written directions;
- Ability to supervise the work of others;
- Ability to enter and maintain computer files;
- Skill in the use of standard automotive trade tools;
- Skill in the use of computers;
- Good motor, hand and eye coordination;
- Manual dexterity;
- Mechanical aptitude;
- Physical condition commensurate with the demands of the position.

MINIMUM QUALIFICATIONS:

One (1) year of satisfactory fulltime paid experience as a skilled Automotive Mechanic in a garage or automotive repair shop. Applicant must possess a valid NYS Heavy Duty Safety and Emissions Certification at the time of appointment and for the duration of employment.

SPECIAL NOTE: A valid NYS Commercial Driver's License (CDL) is required at the time of appointment and for the duration of employment.
